He is a frequent speaker on appellate practice and legal ethics, among other topics, at law school presentations and bar association seminars. He was a member of the governing Council of the American Bar Association Section of Litigation, and he now is a member of the New York State Bar Association Committee on Standards of Attorney Conduct. He is a Fellow of the American Academy of Appellate Lawyers, an organization whose membership is by invitation only and is limited to a total of 500 appellate lawyers in the United States. He also is a member of the Distinguished Alumni Hall of Fame for both Canisius High School and Canisius College.
