#### **EXPERIENCE**

- Cartels: Whether seeking and obtaining leniency or contesting allegations, we handle Department of Justice (DOJ), European Commission (EC) and European national authority cartel investigations and related litigation. Our experience includes compliance, litigation, guiding clients through the antitrust leniency program, responding to grand jury subpoenas, and otherwise navigating communications with the antitrust authorities to avoid or minimize liability.
- Litigation: We represent clients across the United States, United Kingdom and Europe in antitrust litigation, having compiled a remarkable record of resolving antitrust claims through summary disposition, at trial and on appeal against both private and government plaintiffs. In Europe, we have litigated against the EC and national competition authorities before European and Member State courts.
- Mergers: We represent companies in some of the most contentious and complex transactions to come before the authorities for merger review. In the past five years, we have advised on over 150 US HSR reviews worth over \$100 billion. Our team spans the globe and can ably handle simultaneous filings across multiple jurisdictions, including before the FTC, the EC, the UK Competition and Markets Authority and other antitrust authorities. We are also adept at navigating FDI and CFIUS reviews, ensuring compliance with regulatory requirements, and mitigating potential national security risks associated with cross-border transactions.

## **RECENT EXAMPLES OF OUR WORK**

- We successfully represented T-Mobile and Deutsche Telekom at trial in the landmark antitrust challenge brought by state AGs seeking to enjoin the proposed \$26 billion merger between T-Mobile and Sprint. The case represents the first time that state AGs have challenged a national merger after the merger received approval from both the DOJ and the Federal Communications Commission. In addition, our team prepared T-Mobile's CEO for congressional testimony related to the merger.
- We represented private equity firm Welsh, Carson, Anderson & Stowe (WCAS) in an unprecedented FTC litigation over alleged conduct by one of its portfolio companies, which was also a defendant. The court granted our motion to dismiss the FTC's claims against WCAS.
- We advised **Danaher Corporation** on its agreement with General Electric to acquire GE Life Sciences for a purchase price of \$21.4 billion. Our work led to full approval of the transaction by the FTC, the EC, and the Brazilian, Chinese, Israeli, Japanese, Korean and Russian antitrust authorities.
- We achieved a precedent-setting trial victory for **DaVita** in the first-ever trial of a criminal labor market allocation case brought by the DOJ. In April 2022, a federal jury acquitted both the company and its former CEO, Kent Thiry on all charges. This closely watched federal trial was the first involving a company or individual criminally charged for so-called no-poach labor agreements since the DOJ first raised the prospect of criminal prosecution of this conduct in 2016.
