Maya Alexandri was mentioned in a *Portland Phoenix* article regarding the firm's representation of Brian Bartley in charges by officials in Kennebunk, Maine, which claim that his commercial signs violated local ordinances ("Paul Demers - Dogs Restaurateur Over Hebrew National Umbrellas," July 4, 2003, page 14).
