HONORS & AWARDS

Tom Hicks was noted in *Virginia Business* as one of Virginia's top business law lawyers ("The Legal Elite In Its Second Year," December 2001, p. 35).

Seth Waxman was presented with the eighth annual Pursuit of Justice Award, given by the International Association of Jewish Lawyers and Jurists, at a ceremony in the U.S. Supreme Court Chambers on December 11, 2001.
