Ambassador Charlene Barshefsky was interviewed on CNN Financial News ("Before Hours") on November 8, 2001, concerning China's entry into the World Trade Organization, and again on CNN Financial News ("Street Sweep") on November 20, 2001, for a discussion about trade figures and the WTO.
