Under his leadership, among many major matters, the Justice Department obtained more than \$1.5 billion in False Claims Act recoveries, filed a landmark racketeering and damages suit against the major cigarette manufacturers, and successfully litigated the Elian Gonzalez case and the tort actions brought against the federal government arising from the Branch Davidian tragedy at Waco, Texas.

Mr. Ogden joined DOJ in 1995 as Associate Deputy Attorney General and became Counselor to the Attorney General in 1997. He served as Chief of Staff to the Attorney General from 1998 to 1999, after which he was named Assistant Attorney General of the Civil Division (Acting Assistant Attorney General, February 1999 to August 2000). Mr. Ogden was awarded the Attorney General's Medallion in February 1999 and received the Department's highest honor, the Edmund J. Randolph Award, in January 2001. Before joining DOJ, Mr. Ogden was Deputy General Counsel and Legal Counsel at the U.S. Department of Defense. There he directed the Office of Legal Counsel within the Office of the General Counsel and was the recipient of the Department of Defense Medal for Distinguished Public Service, the Defense Department's highest honor accorded to civilians.

Mr. Ogden received his bachelor's degree from the University of Pennsylvania in 1976 and earned his law degree from Harvard Law School in 1981. Following graduation from law school, he clerked a year for Judge Abraham D. Sofaer at the U.S. District Court for the Southern District of New York, then clerked for Justice Harry A. Blackmun at the U.S. Supreme Court for the October 1982 Term.
