### **Seminar – Protecting Confidential Information**

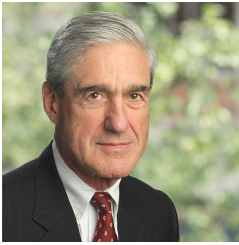

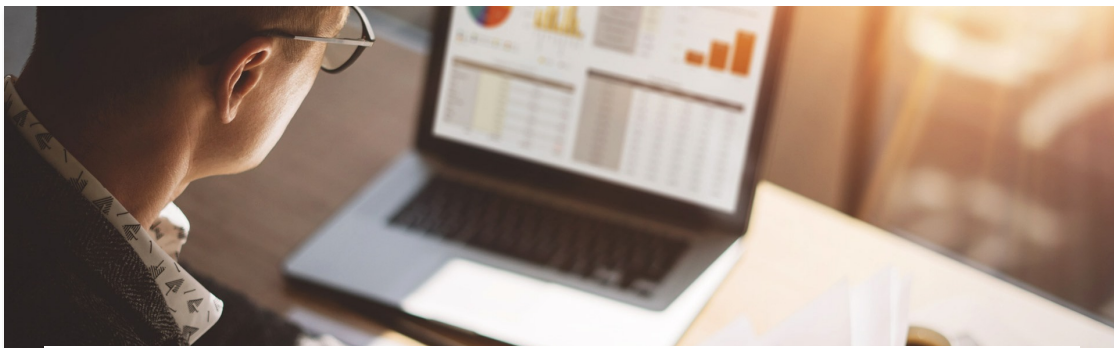
