

The book offers a nuanced analysis of how and when costshifting occurs, parses tribunals' rationalisation of cost assessments, and models the variables most likely to predict costs, using data to point the way towards evidence-based normative reform.

Maxi Scherer, Special Counsel at Wilmer Cutler Pickering Hale and Dorr and Professor of Law at Queen Mary University of London, will deliver opening remarks. Gary Born, Chair of the International Arbitration Practice at Wilmer Cutler Pickering Hale and Dorr; Julian Lew QC of Twenty Essex and Professor of Law at Queen Mary University of London; and Jacomijn van Haersolte-van Hof, Director General at the London Court of International Arbitration, will comment on Professor Franck's presentation.
