After graduating from Columbia Law School, where he was a Harlan Fiske Stone Scholar and an editor of the Law Review, Mr. Rotenberg clerked for Judge Patricia M. Wald of the US Court of Appeals for the DC Circuit. Mr. Rotenberg served in the Department of Justice Office of Legal Counsel before returning to his home state of Minnesota and becoming a partner in a prominent Minneapolis firm. He has also taught at the University of Minnesota and its law school and at the Hebrew University in Jerusalem.
