After leaving the US Attorney's Office, Mr. Mayorkas developed a vibrant civil litigation and internal investigations practice representing a wide range of corporate clients across the country.

Mr. Mayorkas now brings his enormous breadth of experience to WilmerHale. While he will be based in the firm's Washington DC office, he will also devote considerable time to the firm's successful and growing team and capabilities on the West Coast.
