On July 5, 2017, Blue Apron Holdings, Inc. completed its \$300 million initial public offering. Blue Apron's mission is to make incredible home cooking accessible to everyone. Launched in 2012, Blue Apron has grown to \$795 million in annual revenue to become the leading US meal plan delivery company. Shares of Blue Apron's Class A Common Stock are listed on the New York Stock Exchange under the symbol "APRN."
