International Commercial Arbitration and International Investor-State Arbitration

Chambers said: “[Gary Born](#) has represented companies in commercial and investment treaty arbitrations under the auspices of all the leading institutions, including the ICC, LCIA and ICSID as well as in ad hoc arbitrations. His deep expertise includes acting in high-value disputes arising in the energy, insurance and financial services industries, among others. He also has a stellar reputation as an arbitrator.
