- Recognition of foreign judgments (including Uniform Foreign Money Judgments Recognition Act and common law);
- International judicial assistance (including Hague Evidence Convention, Hague Service Convention, and extraterritorial discovery); and
- International arbitration (including New York Convention and Federal Arbitration Act).
