Among other high-level representations, Mr. Pollard represented former Barings trader Nick Leeson; a defendant in the FSA's first criminal prosecution for market manipulation; and a partner of a leading hedge fund facing allegations of market abuse. He has particular expertise in the defense of financial services fraud, internal investigations, multijurisdictional white-collar crime allegations, corruption allegations and competition/cartel allegations.

Mr. Pollard is one of only four *Chambers UK* "Star Individuals" for white-collar crime fraud work. *Chambers UK* has described him as "legendary" and notes that he "has the perfect combination of commercial litigation skills and a criminal law background, and always fights his clients' corner well." *Chambers UK* also lists him as a leading practitioner for financial services work and recommends his cartel defense practice. He is also listed as a leader in his field in the 2011 edition of the *International Who's Who of Business Lawyers*.
