- helped institutions revise their sexual misconduct policies and procedures to meet evolving regulatory requirements;
- handled Title IX and Rehabilitation Act investigations by the US Department of Education Office for Civil Rights and Clery Act investigations by the Office of Federal Student Aid;

Among other notable cases, Mr. Berman defended leading companies in the standardized testing industry in nationwide class actions brought by test takers claiming to have lost educational, scholarship and employment opportunities as a result of erroneous test scores.

In a case that drew national and international attention, Mr. Berman successfully represented an Alabama prisoner sentenced to life without the possibility of parole. As a result of the efforts of a team led by Mr. Berman, the Alabama Supreme Court overturned the client's conviction and he was released after 27 years in prison.
