He has been centrally involved in pioneering transparency litigation, having won a series of cases mandating freedom of access to information held by the EU institutions. He also litigates and represents clients before Dutch, French and Belgian courts (including antitrust damages claims) and competition authorities.

Mr. Louis's competition practice includes behavioral investigations (including internal investigations and leniency applications); complaints and litigation; merger clearances; State Aid investigations; and complaints and counseling. He advises clients across a wide variety of industry sectors, from basic industries (construction materials, chemicals, fertilizers) to consumer goods, including service industries (telecommunications, banking, media and sports).

Mr. Louis's litigation experience before the EU courts ranges over various aspects (including freedom of commerce and constitutional issues) with a focus on competition litigation. Mr. Louis has argued cases before the Grand Chamber of both the General Court and the Court of Justice of the EU.

Mr. Louis has advised Japanese and multinational companies on data protection law and general compliance issues, including jurisdiction and territorial scope, information notices, anonymization and pseudonymisation, cross border flows of personal data, foreign law enforcement requests in the context of cartel investigations issues, and online marketing.

Mr. Louis is antitrust and regulatory counsel to a dozen European and worldwide industry associations. He has advised and litigated on behalf of clients on numerous EU regulatory issues, including advertising, banking, communications, cybersecurity, data protection, energy, environment, health and safety, product liability, public procurement, freedom of commerce and provision of transborder services. He has represented the EU Commission, the European Central Bank and the Single Resolution Board.

CARTEL INVESTIGATIONS AND LITIGATION

Over the years, Mr. Louis has defended a number of clients which were the subject of adverse cartel proceedings initiated by the EC Commission, obtaining mostly favorable outcomes for his clients. He represented Guardian in its appeal to the European Court of Justice, which reduced the fine that the Commission originally imposed in its flat glass decision by over \notin 44 million. He also won a rare annulment of a cartel decision for another clients, as well as a reduction of \notin 205 million on a fine of \notin 326 million imposed by the EU Commission. He is currently involved in multiple investigations before the Commission and several material anti-trust authorities. He has considerable experience in settlement proceedings.

ABUSE OF DOMINANCE

Mr. Louis has filed a number of complaints with the EC Commission alleging abuse of dominance and has defended clients against such allegations. He has won a very rare annulment of a decision imposing an EUR 19 million fine on one of his clients.

BEHAVIORAL COUNSELING

Mr. Louis has particular experience in counseling as to the appropriate industry response under competition law to ESG requirements. He has assisted numerous clients in the structuring of commercial contracts, including joint ventures, R&D co-marketing

agreements, distribution agreements and licenses of intellectual property rights.

Mr. Louis has extensive experience in merger clearances before the European Commission, including transacting in the banking, pharmaceutical, chemicals and communications sectors.
