She has acted as counsel as well as secretary to the tribunal in ad-hoc arbitrations and before major arbitral institutions (including ICC, DIS, VIAC, NAI, CAS), at multiple seats and governed by a variety of substantive and procedural laws. Ms. Braeuer also serves as an arbitrator.

Ms. Braeuer has broad experience in the fields of commercial arbitration, covering a wide range of industries, including telecommunications, luxury consumer goods, pharmaceuticals and energy. Her experience covers an extensive range of commercial disputes, including those arising out of joint venture, shareholder, licensing and distribution agreements. In addition to international commercial arbitrations, Ms. Braeuer's practice includes sports arbitration. She is an arbitrator at the German Court of Arbitration for Sport (DIS-Sportschiedsgericht).

## *Experience*

- Representing a global pharmaceutical company in an ICC arbitration involving a license agreement, sited in Singapore.
- Represented a global biotechnology company in an ICC arbitration arising out of a joint venture with a Korean company.
