# **Experience**

Secured an arbitration award of more than \$100 million for breach of contract—which was paid in full by the losing party—for a major medical device manufacturer.

Successfully defended a Fortune 50 company in a post-acquisition breach of contract case, a 10-day trial in New York that arose from a \$240 million business acquisition.

For Mirror Image International, obtained dismissal of a long-running, \$600 million breach of fiduciary duty case pending in the Delaware Court of Chancery.

Represented Chesapeake Energy who was charged, along with a competitor, by the Michigan Attorney General with price fixing/bid rigging and attempted bid rigging. We handled the civil and criminal investigations, as well as related private litigations, and achieved dismissal of the attempt charge and substantive price fixing charge.

Won a significant victory for a client in litigation in Florida challenging intellectual property outsourcing practices under civil Racketeer Influenced and Corrupt Organization Act (RICO) and federal immigration laws, and representing the same client in employment discrimination litigation concerning the same subject.
