Inspectors general investigate fraud, waste and abuse in the federal government and present a significant enforcement risk for companies and other organizations that receive federal funds or interact with federal agencies. In fiscal year 2021, 75 federal offices of inspectors general closed more than 17,000 investigations, leading to more than 4,000 indictments and criminal informations, 1,000 civil actions, 2,000 suspensions or debarments of government contractors, and \$12 billion in funds recovered.
