## Keane, Inc. Agrees to \$854 Million Acquisition by Caritor, Inc.

(NYSE: KEA) in connection with its proposed \$854 million acquisition by Caritor, Inc. Under the terms of the merger agreement, holders of Keane's common stock will receive \$14.30 per share in cash. The purchase price represents a 19 percent premium over Keane's closing share price on February 6, 2007. The deal is subject to regulatory and Keane shareholder approval and is expected to be completed during the second quarter of 2007.
